Introduction



Medication Training

(this training consists of 3 Tiers in total)

Tier 1 'Online' eLearning training by PrescQIPP



These training courses are delivered in multiple modules:

- **Medicines use in care homes course 1,2,and 3**
- **Managing medicines for adults receiving care in the community – courses 1 and 2**

Course Overview:

These eLearning modules (which carry a NICE endorsement statement and are Skills for Care endorsed) are designed to give learners a foundation knowledge in medicines management within social care and support the implementation of recommendations in the NICE guideline SC1 (Managing medicines in care homes) / NICE Guideline NG67 (Managing medicines for adults receiving social care in the community).

Who is the training for:

Adult social care staff working either in care homes or in the community

Dates Times Venue:

Online E-learning at individual's convenience

Key Learning Points:

Medicines use in care homes:

Course 1 – Safe use of medicines, medicines basics, Medicines Administration Records, general principles of medicines administration, the monthly medicines cycle and self-administration, as well as administration of PRN medicines, solid doses, liquids, inhalers, topical products, transdermal patches and eye drops.

Course 2 - refused and omitted doses, covert administration, controlled drugs, bulk prescribing, homely remedies and waste.

Course 3 - the use of certain 'high risk' or specialist medicines that require specific consideration and/or administration techniques.

Managing medicines for adults receiving social care in the community:

Course 1 – This course is based on NICE Guideline 67 and focuses on the medicine-related processes which social care providers need to consider in relation to medicines use.

Course 2 – This second course focuses on the practical issues relating to the provision of medicines administration support by social care providers

Course Overview:

The online medication training sessions are available for all adult social care staff. Each session will focus on a selected topic and will be a “step up” from Tier 1 eLearning. The sessions will be delivered by the BLMK ICB Care Home Medicines Optimisation team and will focus on local guidance and procedures.

Who is the training for:

Adult social care staff working either in care homes or in the community

How long is the training:

Each Session is 1 hour long

Key Learning Points:

- Homely Remedies* & Self-Care – covers general information, local guidance e.g., Homely Remedies toolkit and listed products, Self-Care Toolkit, case studies and quiz
- When Required (PRN) Medication – covers general information, local PRN guidance including PRN protocols, case studies and quiz
- Covert Administration of Medication – covers general information, legislation, 7-steps approach, case studies and quiz
- Medicines Reconciliation & Transfers of Care – covers general information, resources, case studies and quiz
- Controlled Drugs (CDs) & Regulations in Care Homes* - covers general information, controlled drugs legislation, case studies and quiz

Medication Training – Champion Tier 3

(this training consists of 3 levels in total)



Champions training is being delivered Face to Face in the 1st Quarter of 2024/25 and will be a “pilot to shape future events later in 2024/25. The training will be delivered in person by the BLMK ICB Medicine Optimisation Team

Course Overview: A Care Home Medication Champion is a named individual within the care home who promotes best practice and empowers members of staff, as well as acting as a point of contact for healthcare professionals/practices with regards to medicines. Medication Champions have a keen interest in medicines management.

The training day will be:

- Focussed on troubleshooting, how to implement guidance & best practice and leadership tips.
- Centred around a ‘resident journey’ and case studies.

Key Learning Points:

The training day will cover a workbook which is centred around a new resident joining a care home. It will cover the following sections:

- Introduction and background of new resident
- Changing needs
- Deterioration and increasing needs

Each section will have different scenarios which will promote discussions on how to deal with problems, troubleshooting, how to implement guidance and best practice and leaderships tips.

Oral Health Awareness – Improving Mouth Care

This e-learning enables the implementation of effective oral hygiene measures to help avoid oral complications and the need for dental treatment. Health Education England working across the South East has developed this e-learning package to support the training of all health and care professionals involved in mouth care.

Course Overview:

There are 3 courses available depending on your prior knowledge.

Introduction to Mouth Care – Aimed at new staff or those with little knowledge of mouth care. This level has simple, retainable advice on mouth care.

Mouth Care for Adults – Aimed at carers and covers systemic diseases and how to support individuals. Suitable for staff responsible for assessment and care planning.

Mouth Care for People with Additional Needs – Suitable for staff looking after people with more challenging oral health issues and/or behaviour that makes oral care difficult

Who is the training for:

All adult social care staff working in Care Home Settings with direct care responsibilities.

Key Learning Points:

The 3 modules will:

- Improve understanding of the importance of oral health and the causes of poor oral health
- Demonstrate how to include mouth care in care planning
- Show how to make an oral health needs assessment for each individual using a dedicated assessment tool
- Show how to check a mouth, follow a mouth care plan and what it may include
- Provide up to date information on techniques and products for effective mouth care for natural teeth and dentures
- Show how to help people with their oral hygiene needs if they require support and how to develop strategies for individuals for whom mouth care is challenging.
- Demonstrate how to keep records of mouth care delivered.
- Describe when and how to escalate an oral health problem

Course Overview:

Falls prevention Training- To identify falls risks and how to manage them within a care home setting

Attendees can join individually or as a group – but if you want to join as a group, you **MUST** still register individually, or you will not be recorded as attending.

- To understand why residents, fall and the risks
- To identify ways of reducing the risk of falls

Course Overview:

A face-to-face course looking in greater depth on how to manage residents who have an identified high risk of falls, and how to put care plans in place to meet their needs.

Who is the training for:

All staff working in a care home setting who have completed the Falls Awareness Training.

How long is the training:

1 Day

9.30am to 3.00pm

Key Learning Points:

- Positive risk taking/ Promoting physical activity with your residents
- Falls risk assessments, tools and proactive strategies to manage any identified risk and managing risk assessment reviews
- Care and support plans for those who have fallen
- Methods of dealing with falling and retrieving uninjured clients – practical session

Course Overview:

The course examines the basics around caring for patients who are dying and their relatives.

Who is the training for:

All care staff who have no basic training in Palliative and End of Life Care.

How long is the training:

2.5 hours

Key Learning Points:

- You will be able to understand some of the Terminology used in PEoLC and differentiate between Palliative and End of Life Care
- You will be able to describe the Advance Care Planning Process
- You will understand what the 'normal' dying process looks like and have an explanation for most of the common symptoms
- You'll identify common fears and apprehensions throughout the session and begin to address them
- You'll know what support is available to you and how to access it
- You'll know how to access further training

This course is aimed at equipping care staff with the knowledge, skills and attitudes to become champions, promoting best practice for end-of-life patients within their work environments.

Who is the training for:

All adult social care staff

How long is the training:

2 full days - outlines in key learning points

Key Learning Points:

Day 1 is the Principles of Palliative Care Course and includes the following:

Principles of Palliative Care What is Palliative Care? How does it differ from EOLC or other types of care? How should I interact with these patients? What do these patients want from me? Are there principles that can help me?

Principles of Essential Communication Conversations with palliative/dying patients are often perceived as 'difficult'. Is this true? What do I need to consider? Are there principles that can help me engage effectively with this patient group? This session will build your confidence in your communication skills.

Principles of Advance Care Planning What is Advance Care Planning? Is it important? When should it be done? How should it be approached? Who should commence these conversations?

This training is in accordance with the Dementia Training Standards Framework developed in collaboration by Skills for Health and Health Education England (HEE). Tier 1 and 2 are the recommended awareness programmes for the social care workforce

Tier 1 (Introduction to Living with Dementia)

Raising dementia awareness in knowledge, skills and attitudes for all those working in health and care settings. Relevant to all the workforce including ancillary staff. Suitable for new staff.

Tier 2 (Enabling People to Live Well With Dementia) – (Optional) Knowledge, skills and attitudes for roles that have regular contact with people living with dementia.

How long is the training:

Tier 1 will take approx 40 mins

Tier 2 has 13 modules of up to 40 mins each

Key Learning Points:

- be aware of the prevalence of dementia in the UK population
- be able to recognise signs of dementia and also be aware that these signs may be associated with other conditions or circumstances
- know what actions individuals can take to reduce their risk of dementia, or to delay onset e) know why early diagnosis of dementia is important
- know the actions that people affected by dementia can take in order to live as well as possible after diagnosis
- understand the importance of recognising a person with dementia as a unique individual
- be aware of the impact of dementia on individuals, families and society
- be aware of the central role that their home, housing conditions and immediate community play in enabling a person with dementia to live well
- be able to communicate effectively and compassionately with individuals who have dementia
- understand reasons why a person with dementia may exhibit signs of distress and how behaviours seen in people with dementia may be a means for communicating unmet needs
- be able to signpost individuals, families and carers to dementia advice, support and information.
